**NOTICE IS HEREBY GIVEN** that the following ordinance was adopted on the second reading after a Public Hearing at the Regular Meeting of the Borough Council of the Borough of Emerson on the 16th day of August 2011. **AN ORDINANCE TO AMEND CHAPTER ONE ENTITLED ADMINISTRATIVE LEGISLATION ARTICLE II § 1-15 SCHEDULE OF MINIMUM FINES FOR VIOLATIONS OF THE CODE OF THE BOROUGH OF EMERSON**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Emerson as follows:

**Section 1:** The "Schedule of Minimum Fines" for violations of various sections of the Code of The Borough of Emerson is amended to increase the Traffic violation fees for non-resident parking without a bona-fide Emerson resident decal in the designated Municipal Parking Areas and adherence to the four (4) Ton weight limit on Main Street, Linwood Avenue and Park Avenue as follows:

**Section 2: Severability and Effectiveness Clause:**

- (a) If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.
- (b) Any ordinance inconsistent with the terms of this ordinance is hereby repealed to the extent of such inconsistency.

**Section 3: Effective Date:**

This ordinance shall take effect upon passage and publication according to law.
