**ORDINANCE NO. 1424-11**

**AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF EMERSON CHAPTER 274 THEREOF; ENTITLED VEHICLES AND TRAFFICE § 274-44 SCHEDULE VIII: ENTITLED 'STOP INTERSECTIONS' TO DESIGNATE ADDITIONAL INTERSECTIONS AND INSTALL ADDITIONAL STOP SIGNS**

Be it ordained by the Council of the Borough of Emerson as follows:

**Section I.** Section 274-44 Schedule VIII: Stop Intersections of Chapter 274, Vehicles and Traffic, of the Borough of Emerson , is hereby amended to add the following designated intersections and installation of stop sign sites:
