**AN ORDINANCE AMENDING AND SUPPLEMENTING
CHAPTER 274, VEHICLES AND TRAFFIC; ARTICLE VII, SCHEDULES, SECTION
274-50, SCHEDULE XIV, NO PARKING**

BE IT ORDAINED, by the Borough Council of the Borough of Emerson, County of Bergen and State of New Jersey, that Chapter 274, Vehicles and Traffic; Article VII, Schedules, Section 274-50, Schedule XIV, No Parking of the Code of the Borough of Emerson is hereby amended as follows:

Chapter 274. VEHICLES AND TRAFFIC

Article VII. Schedules

§ 274-50. Schedule XIV: No Parking.

In accordance with the provisions of § **274-21**, no person shall park a vehicle at any time upon any of the following described streets or parts thereof:

Cindy Lane	North	From a point 72 feet east of Forest Avenue for 30 feet to a point 102 feet east of Forest Avenue
Demarest Avenue [Amended 8-21-2012 by Ord. No. 1448]	North	From a point 180 feet west of Kinderkamack Road to a point 270 feet west of Kinderkamack Road thereof where the curblineline intersects with the entrance to the Emerson Convalescent Center parking lot
Emerson Plaza East	East	From Linwood Avenue south for 85 feet
Etna Avenue	Both	Entire length
Etna Avenue	North	From Kinderkamack Road to a point 188 feet west

High Street	East	From Main Street north 160 feet
High Street	West	From Linwood Avenue to a point opposite an extension of the southerly curblineline of Main Street
High Street	West	From a point 383 feet from Linwood Avenue and continuing to a point 50 feet from Palisade Avenue during school days, except that school staff may park in this zone
Hillside Avenue	South	From Birch Street easterly for 1,036 feet to Wortendyke Avenue
Jefferson Avenue	North	From High Street to Kinderkamack Road, except on Sundays between 8:30 a.m. and 1:00 p.m.
Kinderkamack Road	East	From the Borough of Oradell line to the Borough of Westwood line
Kinderkamack Road	West	Entire length, except from a point 100 feet north of Allison Way to a point 328 feet north of Allison Way
Lincoln Boulevard	Both	From the railroad tracks west to Hasbrouck Avenue
Lincoln Boulevard	North	From Kinderkamack Road to the New Jersey Transit Railroad right-of-way
Linwood Avenue	Both	From the railroad tracks west to Hasbrouck Avenue
Linwood Avenue	Both	From Kinderkamack Road to Main Street
Linwood Avenue	North	From Kinderkamack Road to the railroad tracks
Locust Street	North	From High Street to Kinderkamack Road
Lozier Avenue	North	From Kinderkamack Road to a point 230 feet west thereof

Union Street [Added 9-19-2006 by Ord. No. 1311]	East	From Marianna Place to a point 136 feet north thereof
Wortendyke Avenue	West	From Hillside Avenue to Lincoln Boulevard

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.

TITLE

This Ordinance shall be known and may be cited as an Ordinance amending No Parking Regulations.
