**AN ORDINANCE AMENDING CHAPTER 274: VEHICLES AND TRAFFIC  
OF THE CODE OF THE BOROUGH OF EMERSON**

**WHEREAS**, Chapter 274 of the Code of the Borough of Emerson establishes rules and regulations governing parking within the Borough; and

**WHEREAS**, the Mayor and Council wish to amend said Chapter to provide for improved traffic flow; and

**WHEREAS**, the Mayor and Council more specifically wish to improve traffic flow on Ackerman Avenue by prohibiting parking on Ackerman Avenue in between Hasbrouck Avenue and Kinderkamack Road; and

**WHEREAS**, the Mayor and Council believe that it is in the interests of the residents of the Borough to amend said provisions of the Code of the Borough of Emerson to prohibit parking on Ackerman Avenue in between Hasbrouck Avenue and Kinderkamack Road,

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Emerson, in the County of Bergen and State of New Jersey that the following provisions of Chapter 274 of the Code of the Borough of Emerson are hereby amended and supplemented as follows:

**Section 1.** Chapter 274-50 – Schedule XIV: No Parking., is hereby amended to add the following:

§274-50. Schedule XIV: No Parking.

**Section 2.** Chapter 274-52 – Schedule XVI: No Stopping or Standing.. is hereby amended as follows:

§274-52. Schedule XVI: No Stopping or Standing.

Ackerman Avenue	Both	All/All	From Kinderkamack Road to Hasbrouck Avenue

**Section 3.** Chapter 274-53 – Schedule XVII: Time Limit Parking.,. is hereby amended as follows:

§274-53. Schedule XVII: Time Limit Parking.

Ackerman Avenue	Both	3 hrs.; 9:00 a.m. to 4:00 p.m./All	From Sunset Place to Hasbrouck Avenue

**Section 4. Severability and Repealer.**



- B. All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.
