AN ORDINANCE AMENDING CHAPTER 61-10 ENTITLED PARKS, PLAYGROUNDS AND RECREATION, 'FEE SCHEDULE' OF THE BOROUGH OF EMERSON, COUNTY OF BERGEN AND STATE OF NEW JERSEY, ESTABLISHING FEES FOR PARTICIPATION IN RECREATIONAL ACTIVITIES

BE IT ORDAINED by the Mayor and Council of the Borough of Emerson, County of Bergen, State of New Jersey, as follows:

Section 1: Chapter 61 of the Code of the Borough of Emerson, entitled "Parks, Playgrounds and Recreation Department," is hereby amended with the following fees for participation in recreational activities as follows:

§ 61-10: Recreational Activities – Fee Schedule for Participation

Track	
Under 7 years of age	\$70.00
7 years and older	\$100.00
Family Discount	\$20.00 for two \$50.00 for three


Section 2: Severability and Effectiveness Clause:




