CAPITAL ORDINANCE 1611-20

CAPITAL ORDINANCE OF THE BOROUGH OF EMERSON, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS PUBLIC ACQUISITIONS AND IMPROVEMENTS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$147,800 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED by the Borough Council of the Borough of Emerson, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Emerson, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to make the following public acquisitions and improvements in, by and for the Borough: (A) acquisition of an SUV and computer equipment for the use of the Police Department; (B) acquisition of a pickup truck with plow for the use of the Department of Public Works; (C) undertaking of various improvements to public buildings and sidewalks; and (D) acquisition of personal protective equipment and communications equipment for the use of the Fire Department. Said acquisitions and improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$147,800 is hereby appropriated to the payment of the cost of the acquisitions and improvements

authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Borough's Capital Improvement Fund, as hereinafter provided. The sum of \$147,800 is hereby appropriated from the Borough's Capital Improvement Fund to the payment of the cost of said purpose.

Section 3. Said acquisitions and improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said acquisitions and improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
