

LAND USE BOARD OF THE BOROUGH OF EMERSON

**RESOLUTION DESIGNATING THE OFFICIAL NEWSPAPERS FOR THE
PUBLICATION OF ADVERTISEMENTS AND ALL NOTICES REQUIRED BY LAW
TO BE PUBLISHED BY THE BOROUGH OF EMERSON LAND USE BOARD FOR
THE YEAR 2022**

WHEREAS, the New Jersey Municipal Land Use Law, *N.J.S.A.* 40:55D, provides that certain notices required by its terms are to be published in the official newspapers of the municipality; and

WHEREAS, the Open Public Meetings Act, *N.J.S.A.* 10:4-6 et seq., requires that notification be given of meetings of public bodies as therein defined and, in the manner, therein set forth; and

WHEREAS, consistent with such purposes, it has been determined that the newspapers named hereafter are those most likely to inform the people of the Emerson Land Use Board of any public meetings of this body and shall herewith be designated the two newspapers to which public notices required by the Sunshine Law are to be transmitted.

WHEREAS, the Borough of Emerson has by resolution selected the official newspapers of the Borough for publication of legal notices.

THEREFORE, BE IT RESOLVED, by the Borough of Emerson Land Use Board that pursuant to *N.J.S.A.* 40:53-1, the **Record** is hereby designated as the official newspaper for all advertisements and all notices required by law to be published by this municipality and the **Ridgewood News** is hereby designated as an alternate official newspaper; and

BE IT FURTHER RESOLVED, that all notices required to be published shall be placed upon the bulletin board in the main level of Borough Hall, outside the office of the Borough Clerk; and

BE IT FURTHER RESOLVED, that pursuant to *N.J.S.A.* 10:4-19, a copy of this resolution shall be provided to any person who requests a copy of the regular meeting schedule, special or rescheduled meetings of this public body, and upon prepayments by such person of a reasonable sum, if any has been fixed by resolution to cover the costs of providing such notice; and

BE IT FURTHER RESOLVED, that in accordance with *N.J.S.A.* 10:4-14, minutes of the meetings of the Borough of Emerson Land Use Board will be made available for public viewing in the Administration office and on the Borough website. Paper copies of the minutes will be provided to individuals who request same in accordance with the Open Public Records Act, *N.J.S.A.* 47:1A-1 et. seq.
