**MEETING MINUTES**  
**April 10, 2024**

Secretary Marie Shust called the meeting to order at 6:41 PM.,

Ms. Shust asked for a nomination for a Chair Pro Tem since both the Chair and the Vice Chair were not present at the meeting. Ms. Argenzia nominated Mr. DiTota to chair this meeting, second was made by Ms. Fricke. Ms. Argenzia, Ms. Fricke, Mr. DiTota and Mr. Sforza voted yes.

As Mr. DiTota prepared to start the meeting, chairman Colin arrived at the meeting and took over by reading the following: "The New Jersey Open Public Meetings Law was enacted to ensure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interest is discussed or acted upon. **Tree Inspector's Report:**

DPW grown stumps with help from Westwood DPW at the following locations

10 Ridge Rd.

10 Ridge Terr.

16 Granger Rd.

143 Munsey Rd.

262 Kinderkamack R.

DPW trimmed branches around Benkovic field to help with the new lighting.

DPW removed a dead Maple tree at 140 Demarest Ave.

DPW trimmed several trees of dead branches located at 153 & 177 Jordan Rd. and 4 Alan Rd.

We had two large Oak trees leaning at the rear of 5 Linden Ave. I had to call Jeff Smith tree service to do an emergency removal because a crane is also needed.

### **Minutes of February 12, 2024 meeting:**

Vice Chairman Grzybowski asked if there were any questions or corrections for the minutes of February 12, 2024, Ms. Shust said there was an error in the attendance for Mr. Solimando and Mr. DiTota, they were both present at the February meeting. Vice Chair Grzybowski made a motion to approve the amended minutes, which was seconded by Mr. Esqueu. All were in favor.

### **Vouchers & Correspondence:**

There is one voucher from Gannett Newspapers for the publication of the 2024 meeting dates in the Record and The Ridgewood News in the amount of \$36.38.

Vice Chairman Grzybowski made a motion to approve the invoice. Second was offered by Mr. DiTota. Vice Chairman Grzybowski, Ms. Fricke, Mr. DiTota, Mr. Esqueu, Ms. Argenzia, Mr. Lauterback and Mr. Sforza voted to approve payment.

### **2024 Budget**

The Vice Chair quickly reviewed the budget which still only reflects the first quarter allotment. Councilman Gordon told the members the budget had not been approved.

### **Continuing Business:**

#### **Spring Planting:**

Mr. Grzybowski told the members he had emailed the residents who had requested trees about their selections. He asked Ms. Shust to send out the spreadsheet to all the members and requested any member on the list to submit their selection if not already done.

Mr. Sforza asked for the booklet to be sent to him. Ms. Shust gave him a copy to review and he was to advise the Vice Chair of his selection. For the most part Ginko trees had been selected.

Mr. Grzybowski stated he would like to break down to 2 plantings one in March, one in April to make it easier for DPW. Mr. DiTota stressed how important watering a new tree is to its survival.

### **2024 Arbor Day Ceremony**

Ms. Argenzia advised the members the ceremony was scheduled for April 27 at Sunset Park. Since the other events scheduled for that day had been rescheduled, she

asked what time the members would like to hold the event. They agreed on 10AM, and also chose an Oak tree to be planted.

### **Tree City USA**

Ms. Fricke told the members that the application was being processed, however, more information was requested in regards to the previous years ceremony. Ms. Shust and Ms. Argenzia said they would find the information she needed.

### **Webpage update:**

Ms. Shust told Mr. Lauterback to reach out to Triessa, the Deputy Clerk in the Borough, for assistance with updating the webpage, as there is a contractual agreement in place and certain things cannot be changed without approval.

### **Streetscape & Tree Species:**

Mr. DiTota agreed that some of the trees listed on the streetscape were not suitable for traffic areas and some were not shade trees. He said he would work on the list.

### **Tree Management Form:**

Since chairman Colin was not present the form was tabled to the next meeting.

### **Valero**

Mr. Grzybowski closed the file on Valero, since Mr. Solimando and Mr. DiTota agreed that all planting had been done.

### **Open to Public:**

There was no one in the Chambers so the floor was not opened.

### **Member commentary:**

Mr. Solimando told the members he needed to have personnel trained on the Bucket Truck. He said would research pricing for training and report at the next meeting.

Mr. Esqueue asked about storm damage. Mr. Solimando replied it had been minimal.

### **Adjournment:**

Having no other business to discuss, the Vice Chair asked for a motion to adjourn which was made by Mr. Esqueu, second by Mr. Sforza all were in favor.

The meeting was adjourned at 7:18 pm.
